EXPLANATORY STATEMENT PURSUANT TO SECTION 102(1) OF THE COMPANIES ACT, 2013

Item No. 1:

TO CONSIDER AND APPROVE ISSUE OF NON-CONVERTIBLE DEBENTURES FOR AN AMOUNT UPTO RS. 2500 CRORES:

The Members of the Company at their meeting held on March 21, 2023, had approved the issuance and allotment of secured, unsecured, perpetual, listed and/or unlisted Non-Convertible Debentures including subordinated Debentures qualifying as Tier-II debt upto Rs.3,500 Crores and the same was valid for a period of 1 year from the date of approval.

Now, in order to meet the fund requirements of the Company for the purpose of business expansion and to tap the enormous growth potential in the market, it is proposed to raise funds by way of offer, issue and allotment of secured, unsecured, perpetual, listed and/or unlisted Non-Convertible Debentures including subordinated Debentures qualifying as Tier-II Debt ("NCDs") in terms of the relevant RBI Master Directions for an amount upto Rs. 2500 Crores to eligible investors on a private placement basis in one or more tranches.

In terms of Rule 14 of the Companies (Prospectus and Allotment of Securities) Rules, 2014, it shall be sufficient if the Company passes a special resolution only once in a year for all the offers or invitations for issuance of Debentures during the year.

The Board at its meeting held on March 16, 2024 had approved the issuance of NCDs for an amount upto Rs. 2500 Crores to eligible investors on a private placement basis in one or more tranches.

The NCDs may be issued at par or at a premium or discount and may be listed on the Stock Exchange(s) and, on such other terms and conditions as the Board / Committee of the Board may determine.


