## SUMMARY OF PROCEEDINGS OF THE 32<sup>ND</sup> ANNUAL GENERAL MEETING OF ALPHA ALTERNATIVES FINANCIAL SERVICES PRIVATE LIMITED HELD ON 16<sup>TH</sup> SEPTEMBER, 2025 COMMENCED AT 10:00 A.M. AT THE REGISTERED OFFICE OF THE COMPANY AND CONCLUDED AT 10:45 A.M.

The 32<sup>nd</sup> Annual General Meeting ("AGM") of the Members of the Company was held on 16<sup>th</sup> September, 2025 at 10:00 a.m. at the registered office of the Company at 34<sup>th</sup> Floor, Sunshine Tower, Senapati Bapat Marg, Dadar (West), Mumbai – 400 013.

Mr. Shreyans Mehta, Executive Director, Mr. Amit Kothari, Executive Director, Mr. Naresh Kothari, Non-Executive Non-Independent Director, Mr. Pradeep Parakh, Independent Director and Chairperson of Audit Committee and Stakeholder Relationship Committee and Mrs. Bharati Aindley, Independent Director and Chairperson of Nomination and Remuneration Committee were present in the meeting. Ms. Sharmila Karve, Independent Director of the Company could not attend the meeting due to her personal exigencies. The Directors present at the AGM appointed Mr. Shreyans Mehta as the Chairperson of the meeting.

Further, Mr. Jay Paleja, Chief Financial Officer of the Company was also present at the Meeting.

The Chairperson declared that two members including one authorised representative of Alpha Alternatives Holdings Private Limited, the holding company, representing 1,59,56,180 equity shares constituting 100% of the paid-up share capital of the Company were present at the meeting. Accordingly, it was ascertained that the requisite quorum was present for the meeting.

The representative of the Statutory and Secretarial Auditor's due to their personal exigencies could not attend the meeting.

The Chairperson stated that the notice of the AGM along with explanatory statement, Annual Report, containing Audited Standalone Financial Statements, Board's Report and its relevant annexures and Auditors' Reports for the year ended March 31, 2025, have been sent by electronic mode to those members whose e-mail addresses are registered/communicated to the Company. Considering the above, the Notice was taken as read.

The Chairperson informed the members that the registers and documents, as statutorily required to be made available at the AGM, were available for inspection during the meeting.

The Chairperson informed the members that the Statutory Auditors' Report and Secretarial Audit Report did not have any qualifications.

The Chairperson then gave a brief overview of the performance of the Company for the financial year ended March 31, 2025, and briefed on the business outlook.
